(e)	16.08.2017 (Wednesday)	as the date for publication of the final list of contesting candidates (after 3:00 PM)
(f)	29.08.2017 (Tuesday)	as the date on which a Poll shall, if necessary, be taken (from 7:00 AM to 5:00 PM)
(g)	31.08.2017 (Thursday)	as the date on which a Repoll, if any, shall be taken (from 7:00 AM to 5:00 PM)
(h)	01.09.2017 (Friday)	as the date of Counting (from 8:00 AM onwards)
