WHEREAS, the State Election Commission notified election to the offices of Mayor/Dy.Mayor of Greater Hyderabad Municipal Corporation in its notification No.1107/SEC-F1/2009-3, dt:28.10.2009 and as per the schedule appended thereto 6<sup>th</sup> December, 2009 at 11.00 AM is fixed as the date and time of the meeting for the election of Mayor /Dy.Mayor;

AND WHEREAS, representations have been received by the Commission that as the 6<sup>th</sup> December, 2009 is observed as Black Day by certain communities that date would not be conducive for the election of Mayor/Dy.Mayor and therefore, the special meeting for the election of Mayor/Dy.Mayor may be held on a different date;

AND WHEREAS, the State Election Commission after careful consideration of the representations is of the view that it is desirable to change the date of election of Mayor/Dy.Mayor of the Greater Hyderabad Municipal Corporation;

NOW THEREFORE, in exercise of the powers conferred by Article 243-K read with 243-ZA of the Constitution, sections 9, 10 and 90 of Greater Hyderabad Municipal Corporation Act, 1955 (Act 2 of 1956) and rule 3 of AP Municipal Corporations (Conduct of Election of Mayor and Dy.Mayor) Rules, 2005 and in supersession of the notification issued in reference No. No.1107/SEC-F1/2009-3, dt:28.10.2009, the State Election Commissioner, hereby, directs the Election Authority & Commissioner & Special Officer, GHMC, Hyderabad to authorise one of the District Collectors having jurisdiction over any area

comprised in the Greater Hyderabad Municipal Corporation to conduct election to the office of Mayor and Deputy Mayor of the Greater Hyderabad Municipal Corporation in accordance with the procedure laid down in the said Act and Rules made thereunder and fixes the revised schedule for the said election in the annexure appended to this Notification.
